Welcomes, Introductions, Announcements were made.

RCFY Executive Director Celeste opened the meeting by introducing Laurie Warnock of NH Poison Control. She reported on Marijuana exposures (Poisoning.) This is not for medical use but recreational use. In the state where it is legalized (VT & MA) the instances are higher than NH. Typically the 1st wave of calls to the center a state learns about what they are dealing with and then address issue themselves. There were 22 NH children between age of 0 - 5 who experienced poisonings in 2021. Calls are mostly for edibles where youngsters are more apt to eat more than suggested.

Another increase is in 11-13 year olds overdosing on over the counter products, ex: acetaminophen. This can effect major organs and symptoms don't show up until hours later. Numbers are not high but it is a red flag for the center. Suicide kits will be shared when they become available.

The second speaker for today is Danielle Ellston or NH Liquor Enforcement. There is a bill HB1591 being presented that will eliminate the liquor enforcement regulatory arm. If this passes all enforcement will fall to local authorities. The NH LEA is the primary law enforcement for tobacco and this would also fall on local authorities to deal with.

The NHLE partners with HHS to do compliance checks and there is a 3 year strategic plan that will do checks on every establishment for alcohol and tobacco.

DHC, FedEX and UPS no longer will ship electronic tobacco products.

Counterfeit vape products are everywhere and can be readily purchased at your local convenience store.
